

1. DEFINITIONS

“License” shall mean the terms and conditions for use, reproduction, and distribution as defined by Sections 1 through 5 of this text.

“Licensor” shall mean the copyright owner that is granting the License.

“You” (or “Your”) shall mean an individual or Legal Entity exercising permissions granted by this License.

“Software” shall mean the StatSilk group of software, including StatPlanet, StatPlanet Plus, StatPlanet Lite, StatTrends, StatTrends Plus and StatWorld.

“StatPlanet Plus” is an advanced version of the free StatPlanet mapping and visualization software.

2.1. StatPlanet, StatPlanet Lite and StatTrends have no restrictions on use, and may be freely used, publically displayed, publically performed, and copied and distributed through any website or media without permission for both commercial and non-commercial use, subject to 2.4 below. Please note that there is currently no free desktop version of StatTrends for commercial use.

2.2. StatPlanet Plus and StatTrends Plus have restrictions on use and distribution. The web version of StatPlanet Plus requires a license for use by both Commercial and Non-profit Entities, and may only be used on the web-domain(s) to which it is licensed. The desktop version of StatPlanet Plus may be freely used, publically displayed, publically performed, and copied and distributed through any website or media without permission by Non-profit Entities, subject to 2.4 below. The desktop version of StatPlanet Plus requires a license to be used by Commercial Entities, and may only be used by the Commercial Entity and/or employees of the Commercial Entity which purchased the license.

2.3. The rights and restrictions described in 2.2 above do not apply for local organizations and government institutions in low income countries. Local organizations and government institutions in low income countries may freely use, publically display and publically perform StatPlanet Plus and StatTrends Plus as well publish StatPlanet Plus and StatTrends Plus on their website provided that the organization only operates in low income countries and uses a web domain belonging to a low income country.
